Early Learning Support Staff (Early Learning School-Based)

POSITION DETAILS:

- Serve as a support staff for 3-year-old or 4-year-old classrooms
- Under the guidance of the lead staff, supervise a group of children while maintaining a safe and healthy classroom environment, following all staterequired childcare licensing and PATHS to Quality program requirements.
- Maintain a safe and healthy classroom environment for the children and follow all state-mandated childcare licensing and PATHS to Quality program requirements.
- Attend to children's basic needs, including feeding and diapering, and adhering to classroom cleaning and sanitizing procedures.
- Under the guidance of the lead staff, assist in the creation of a classroom community for teachers, children, and families.
- Under the guidance of the lead staff, assist in planning and implementing developmentally-appropriate materials, activities, and lesson plans.
- Under the guidance of the lead staff, assist in planning a developmentallyappropriate classroom environment.
- Under the guidance of the lead staff, assist in the completion of child assessments.
- Obtain 20 hours of professional development per year.
- Stay updated on all state-license mandated requirements including: CPR/First-Aid training, Child Abuse and Neglect Detection training, Background Checks, Fingerprinting, etc.
- Perform other duties as required.
- 8.0 hours per day, Monday Friday

- Must be physically able to perform the job of a teacher of young children.
- Must be flexible in receiving assignment or adapting to changes in the program
- Must be willing to accept supervision to improve work performance.
